**FBI agents have testified before congress raising serious concerns about "resettlement programs" in the United States this year.**

WND has found that dozens of criminals and terrorists have been allowed into the country as "refugees," and asylum seekers. Two al-Qaida terrorists from Iraq were resettled in Bowling Green, Kentucky, an Uzbek terrorist was resettled in Boise, Idaho, and dozens of Somali terrorists and terrorist sympathizers have been resettled in Minnesota, Maine, Ohio and Virginia. **Point:** We don't know who we are getting. The vetting process is a serious problem. For example Syria has no criminal database. In just the past year, Sen. Jeff Sessions has documented 72 cases in which likely Muslim immigrants have been arrested and charged with terror-related crimes.

Of the Syrians who have already come to the U.S. as refugees, 95 percent have been Muslim and only 3.8 percent Christian.
